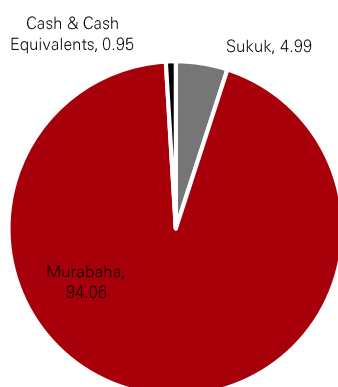

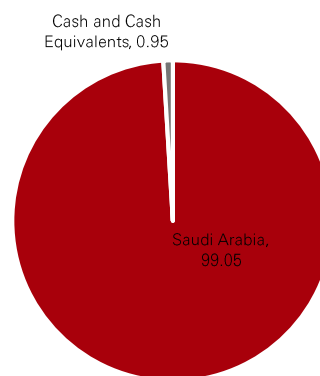

### Asset Allocation (%) <sup>(4)</sup>

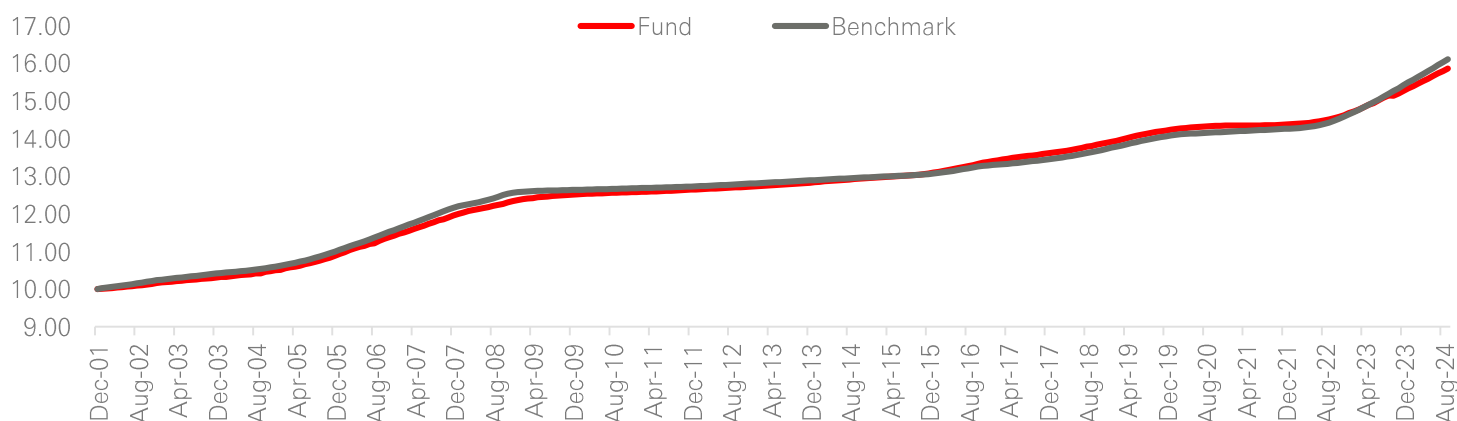


### Geographical Allocation (%) <sup>(4)</sup>
